

**City of Chandler  
Council Minutes  
September 8, 2014  
7:00 pm**

1. The meeting was called to order by Mayor Gary Stoner.
2. Members present: Mayor Gary Stoner; Council Members: Don Buys, LeRoy Buys, Doug Schuur and Bill DeKruif; Public Works: Jeff Gunnink; City Clerk: Kris Gunnink; Audrey Bruxvoort.
3. Pledge of Allegiance to the Flag.
4. Doug Schuur made a motion to approve the minutes of the August 11, 2014 meeting. LeRoy Buys supported the motion. Passed (yea 5, nay 0).
5. Doug Schuur moved to accept the financial reports and bills paid for the City of Chandler and Chandler Fire Department. Don Buys supported the motion. Passed (yea 5, nay 0).
6. Doug Schuur moved to put \$35,000.00 in a general fund CD from the water fund. Don Buys seconded the motion. Passed (yea 5, nay 0).
7. Doug Schuur made a motion to fund the City Clerks wages from 50% general fund, 16.67% water fund and 33.33% sewer fund. The Clerk wage was taken previously from 100% general fund. Don Buys seconded the motion. Passed (yea 5, nay 0).
8. Bill DeKruif moved to approve Audrey Bruxvoort building permit with driveway repair plans approved by Jeff Gunnink-Public Works and Doug Schuur-Street Supervisor. Don Buys seconded the motion. Passed (yea 5, nay 0).
9. Leroy Buys moved to approve Lonnie Clark building permit at 350 3<sup>rd</sup> St. to put in a driveway. Doug Schuur seconded the motion. Passed (yea 5, nay 0).
10. Curb repair on Valley View Avenue and 7<sup>th</sup> Street is complete at a cost of \$4072.13. There is some black top filling in and repair left.
11. Property in question on Valley View Ave is owned by Allen Prins. Council recommends that Allen Prins update the abstract for the property and then will be able to turn over to the City the area with the spillway located on it.
12. Leroy Buys moved and Bill DeKruif supported the motion to update the Minnesota Basic Code of Ordinances and properly publish and adopt the updated Code of Ordinances for the City of Chandler. Passed (yea 5, nay 0).
13. Bill DeKruif moved to have an addendum for the current SIU with Monogram Foods LLC. With keeping the same limits as per the original agreement, another 5 years from this meeting on. Doug Schuur seconded the motion. Passed (yea 5, nay 0).

14. Don Buys moved to pay for the MN Mayor dues and the League of Minnesota Cities membership dues. Doug Schuur supported the motion. Passed (yea 5, nay 0).
15. Don Buys moved to set a 10% increase in the preliminary Levy to the Murray County Auditor for the City of Chandler. Bill DeKruif seconded the motion. Passed (yea 5, nay 0).
16. Council discussed security issues within the City of Chandler and if there is a need for surveillance equipment. No action was taken at this time.
17. City Clerk will look into what other Cities and townships are paying election judges per hour.
18. An interested community member asked about holding a Zumba class at the community center. Details are still pending.
19. Concept minutes were read.
20. Bill DeKruif move to adjourn. Doug Schuur seconded the motion. Passed (yea 5, nay 0).
