

**City of Chandler
Council Minutes
December 14, 2015
7:00 pm**

- 1) The meeting was called to order by Mayor Daryl Behrends.
- 2) Members Present: Mayor Daryl Behrends, Council members; Don Buys, LeRoy Buys, Bob Prins and Faye Schuur; Clerk, Kris Gunnink. Water/Waste Water Operator, Jeff Gunnink; Fire Chief, Dan Gunnink; Jessica Kooiman
- 3) Pledge of Allegiance to the Flag.
- 4) Mayor asked if there were any changes or corrections to the agenda. Added: Murray county police contract and stop sign located by east corner of 2nd St. and Carlton Ave. Remove old business regarding needing a resolution regarding water/ sewer, as it was properly passed in a previous meeting. Bob Prins moved to accept the amended agenda. Faye Schuur seconded the motion. Motion carried
- 5) LeRoy Buys moved to approve the minutes of the November 9, 2015 Council Meeting. Don Buys seconded the motion to accept the minutes. Motion carried.
- 6) Bob Prins moved and Faye Schuur seconded the motion to approve the Financial Reports for the City and Fire Departments. Motion Carried.
- 7) City maintenance will replace the stop sign with a yield sign on the east side of the intersection of 2nd St. and Carlton Ave. This replacement is due to slipping/losing momentum at that stop sign in the winter time street conditions.
- 8) Fire Chief, Dan Gunnink, reported that Lonnie Clark and Kevin Tinklenberg both resigned from the Fire Department. Dan thanked the City for the continued support of the fire department.
- 9) Jessica Kooiman spoke with the City Council. She will be opening a hair and nail salon in the City Center. Jessica would like to open for business February 1, 2016.
- 10) Faye Schuur moved to charge \$50.00 per month for the first year of business for the use of the hair salon in the city center. Don Buys seconded the motion. Motion carried.
- 11) Faye moved to set the general tax levy at \$105,483.00. This is a 3% increase. Don Buys seconded the motion. Motion carried.
- 12) Bob Prins moved to approve Resolution #2015-5 regarding the general tax set at \$105,483.00. LeRoy Buys seconded the motion. Motion carried.
- 13) Faye Schuur moved to accept Minnesota Rural Water Association proposal to GIS Map and GPS Data collection for the City's water lines. LeRoy Buys seconded the motion. Motion carried.
- 14) City clerk will revise the Community Center Rental Agreement and damage clause.

- 15) City Council has been informed that the City of Chandler is one of the Cities in Murray County that qualifies for the Single Family Repair Loan Program. The City Clerk will be including the contact information in the January Water/Sewer billing.
- 16) Don Buys approved the Murray County Law Enforcement Contract for 2016. Bob Prins seconded the motion. Motion carried.
