

**City of Chandler
Council Minutes
July 11, 2016
7:00 pm**

- 1) The meeting was called to order by Mayor Daryl Behrends.
- 2) Members and Guests Present: Mayor; Daryl Behrends, Council members; LeRoy Buys, Don Buys, Faye Schuur, Robert Prins; Clerk, Kris Gunnink; City Maintenance/Waste Water Supervisor, Jeff Gunnink; Guests, John and Caryl Busman.
- 3) Pledge of Allegiance to the Flag.
- 4) Don Buys moved to approve the Minutes of the June 13, 2016 Council Meeting. Seconded by Faye Schuur. Motion carried.
- 5) Bob Prins moved to approve the Financial Reports for the City and Fire Departments. Seconded by Don Buys. Motion carried.
- 6) Correspondence- Monogram Meats have informed the City of Chandler that they are currently out of compliance according to the SIU agreement
- 7) Mosquito Control has sprayed in Chandler several times in the month of June.
- 8) Faye Schuur moved to table the building permit for 111 Carlton Ave. Bob Prins seconded the motion. Motion carried. The city council is requesting more information on access to building and concerns on building size.
- 9) Community Center fundraiser for new park equipment raised approximately \$1800.00.
- 10) The City Clerk has sent out letter to residences that have nuisance vehicles according to the City of Chandler Ordinances.
- 11) LeRoy Buys made a motion to allow the Property owners of 220 2nd street to tear down the house. They plan on keeping the garage on the property. Bob Prins seconded the motion. Motion carried.
- 12) LeRoy Buys moved to purchase 3 hand sanitizers to be placed in the City park restrooms and shelter house. Faye Schuur seconded the motion. Motion carried.
- 13) Election Judge hourly rate was discussed. Pay was increased to \$15.00 in 2014. City Council decided to have the hourly rate remain the same.
- 14) City Clerk will work on drafting an official complaint policy for the City of Chandler to adopt and implement.

- 15) Don Buys moved to approve Patsy Buys to work the city clerk office hours on August 16 from 1:00 pm to 5:00 pm, as required by law, with election judge hourly wage. This is for the registration of advocacy to be on the November ballot for City Council and Mayor. Faye Schuur seconded the motion. Motion carried 4-0. LeRoy Buys abstained from voting.
- 16) Sharon VandeVoort had questions in regards to holding an event this fall. City Council referred her to get permission from the Chandler Economic Development.
- 17) LeRoy Buys moved to approve the concept minutes. Seconded by Bob Prins. Motion carried

- 19) Faye Schuur made a motion to adjourn the meeting. Bob Prins seconded the motion. Motion carried.
